## **RECOMMENDATION(S):**

THAT Report 25-004-CRS Appointment of Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer be received;

AND THAT the by-law attached as Appendix "A" to Report 25-004-CRS providing for the appointment of an Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer for the Corporation of the City of Cambridge, be enacted.

## **EXECUTIVE SUMMARY:**

#### **Purpose**

To recommend the passing of an amendment to By-law 119-08 to appoint an Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer for the Corporation.

## **Key Findings**

The appointment of an Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer are required while the recruitment for a new Chief Financial Officer is underway.

It is deemed appropriate at this time to bring forward an amendment to By-law 119-08, providing for the appointment of Officers of the Corporation of the City of Cambridge, in

order to appoint an Acting Chief Financial Officer and Acting Deputy Treasurer to facilitate the conduct of the business of the Corporation.

The appointment of an Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer ensures that the decisions of Council can be implemented in a timely and fiscally prudent manner and that legislative responsibilities can be fulfilled.

#### **BACKGROUND:**

The Municipal Act, 2001, authorizes the Council of a municipality to select and appoint Municipal Officers, namely a Clerk, Treasurer and Deputy Clerks and Treasurers, as required.

Section 227 of the Municipal Act, 2001, further establishes the roles and responsibilities of Municipal Officers and employees to:

- Implement Council's decisions and establish administrative practices and procedures to carry out Council's decisions;
- Undertake research and provide advice to Council on the policies and programs of the municipality; and
- To carry out other duties required under any Act and other duties assigned by the municipality.

On August 11, 2008, Council passed By-law 119-08, providing for the appointment of Officers of the Corporation of the City of Cambridge tasked with responsibility for carrying out and enforcing regulations in accordance with the applicable policies and by-law(s) and performing the duties established by the job description approved for the position(s) by the Corporation of the City of Cambridge.

#### ANALYSIS:

In review of the appointment By-law 119-08, staff determined that it was appropriate to amend the by-law to appoint an Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer to act while the recruitment for the Chief Financial Officer position is underway.

Historically, Cambridge City Council has appointed Municipal Officers by name; however, in an effort to maintain up-to-date appointment information and authorization, a comprehensive review of By-law 119-08 will be undertaken in 2025. Upon completion of this review, staff will recommend that City Council consider appointing by position title rather than by employee name.

# **EXISTING POLICY / BY-LAW(S):**

The appointments recommended in this report require an amendment to By-law 119-08. The draft amending by-law is attached to this report as Appendix 'A' and will be presented to Council for enactment concurrently with this report.

## **FINANCIAL IMPACT:**

There is no financial impact pertaining to the appointment of an Acting Chief Financial Officer / Treasurer and Acting Deputy Chief Financial Officer / Deputy Treasurer for the Corporation, as the recommended appointments pertain to existing positions.
