5.1 Public Meeting - Proposed Official Plan and Zoning By-Law Amendment -8 Schofield Street

Council provided staff with the following directions:

- Ensure that the proposed development has entrances that are barrier-free and accessible:
- Inquire into retaining the landscape features on the subject lands;
- Inquire into creating assigned visitor parking on the subject lands and further parking opportunities;
- Inquire into incorporating the 2022 Forecasted Parking Demand Parking Study to accurately reflect the needs of potential future residents;
- Inquire into drainage and its impacts;
- Inquire into options to extend the party and fitness rooms into two separate spaces or one large amenity space for either a fitness room or party room;
- Inquire into alternative landscaping features separate and apart from the various planters located throughout the subject lands to ensure a proper barrier for any runoff;
- Inquire into the construction of an appropriate sound barrier wall;
- Staff are to confirm with Transportation whether the City has plans to create sidewalks in the surrounding areas;
- Inquire into reducing the proposed development density; and
- Inquire into unit variation, including three-bedroom units to accommodate families.

- Inquire into whether it is possible to create a path for residents to access local schools and the community centre to mitigate potential effects to the Open Space;
