#### **EXECUTIVE SUMMARY:**

## **Purpose**

The purpose of this report is to seek Council's approval for the appointment of auditors and the slate of Board of Directors for 2025 as recommended by GrandBridge Corporation Board of Directors, because the City of Cambridge is a major shareholder of GrandBridge Energy.

This report is presented to Council each year and forms part of the submission to GrandBridge at the Annual General Meeting. The Annual General Meeting for GrandBridge is scheduled for Thursday, May 22nd, 2025.

## **Key Findings**

The audit firm of KPMG is being recommended for appointment by GrandBridge Corporation Board of Directors for the fiscal year 2025 along with the slate of Board of Directors noted in the recommendation of this report.

There are no financial impacts to the City of Cambridge 2025 budget associated with either the appointment of KPMG or the slate of Board of Directors for GrandBridge Corporation.

#### **BACKGROUND:**

As a major shareholder owning 54.3% interest in GrandBridge Corporation, the City of Cambridge, through its Council, is required to approve the appointment of auditors on an annual basis.

In accordance with Article 3(d) of the Unanimous Shareholders Agreement, the initial three (3) year term of the Board of Directions ended on May 2, 2025. As such, the slate of seven (7) directors put forward for approval in the recommendation of this report were nominated by the GrandBridge Corporation Board of Directors and also require approval by each shareholder.

The shareholders for GrandBridge are the City of Cambridge (majority shareholder at 54.3%), the City of Brantford (41%) and the Township of North Dumfries (4.7%). Included as Attachment 1 to this report is correspondence from GrandBridge, dated March 31, 2025, requesting that Cambridge Council, in their role as shareholder approve the appointment of auditors for the fiscal year 2025 and the slate of Board of Directors.

In accordance with Article 3.2(d) of the Unanimous Shareholders Agreement, the following individuals also serve on the Board of GrandBridge Corporation as the Mayor or Mayor's Alternates:

Mayor of Cambridge, Jan Liggett Mayor's Alternate, City of Brantford, Councillor Greg Martin Mayor of North Dumfries, Susan Foxton

#### **ANALYSIS:**

The Board of Directors, consistent with their fiduciary responsibilities, have made a recommendation to the shareholders (Cities of Cambridge and Brantford and the Township of North Dumfries) with respect to the appointment of auditors and the slate of Board of Directors for the year 2025. City staff have a very good working relationship with the President and CEO, the Board of Directors and the Auditors for GrandBridge. Staff do not have any concerns with respect to the recommendations of the Board of Directors to appoint KPMG as the auditors for the fiscal year 2025 or with the slate of Board of Directors for GrandBridge Corporation.
