The regular meeting of the Cambridge Environmental Advisory Committee (CEAC) was held in the Secord Room, 50 Dickson Street, Cambridge, Ontario. Kathy Padgett welcomed everyone to the meeting and the meeting was called to order at 7:04 p.m.

Delegations

Dani Lindamood provided a delegation on supporting the need for Provincial action on salt pollution from road salt. Ontario is responsible for the application of 2.2 million tonnes of salt each year which is creating serious negative effects to drinking water, the ecosystem, infrastructure, businesses and personal goods.

Currently, there are no provincial policies or regulations for road salt. Contractors have no way of proving they have done a sufficient job, leading to oversalting. At the same time, municipalities have no mechanism to address salt pollution.

The Ontario Salt Pollution Coalition (OSPC) is working to develop a non-partisan policy solution to address the issue of winter salt management. 'Limited Liability' is a policy approach used in similar jurisdictions to increase safety outcomes and reduce environmental harms. Limited Liability Legislation includes: required contractor training; Provincially-endorsed Best Management

Practices and standards; legislation limiting snow and ice management contractor liability; and establishing a Provincial regulatory authority.

Locally, concerned municipalities are passing resolutions urging the Province to work with key stakeholders to develop legislation to deal with the issue.

The Committee thanked Dani for her presentation and discussed the impacts of salt pollution on Cambridge's drinking water and natural environment, noting that public awareness is an important part of creating change. The Committee indicated their support for bringing a resolution to Cambridge Council

Review of Meeting Notes and Action Items

The CG group reviewed the Meeting Notes and carried forward Action Items.

City Green in the Community

1. Cambridge Bee City Team

Background:

The Cambridge Bee City Team meets 3 times a year (February 6, June 5, November 6, 10-11:30 a.m.); City Green members are welcome to attend. <u>Click here to join the next meeting</u>. Project information is available online at the Bee City Canada <u>website</u>.

Aspects Discussed During This Meeting:

- CG members were reminded of the June 5th meeting. This meeting will discuss the March 8th Bee City Seedy Saturday event and recommendations for next year.
- PW noted that the Ancient Mariners will once again be planting (May 22nd) at the Cambridge Pollinator Preserve.

2. Mill Creek Project

Mill Creek Subcommittee: Kelly, Linda, Diane, Moira.

Background:

After hosting a number of Jane's Walk events along Mill Creek (from Soper Park to the Pedestrian Bridge) the CG group felt a self-directed walk could be enjoyed by people year-round. The "walk" would involve an online resource and the installation of small steel signs along the route with QR codes at "points of interest" where people could access historical photos and a description of how the creek has changed over time. The online platform would be similar to the <u>Historic Downtown Walking tour</u>.

An example using the same online format is the <u>Cambridge Natural Heritage Tour</u> which was a Cambridge Environmental Advisory Committee project (i.e. a 50-page booklet brochure) that City Green volunteers transformed into an online resource. CG volunteers would write the text and gather a photo for each "point of interest" along the walking route. All files for the project are available <u>here at this Sharepoint site</u> (permission is required to access the site, currently only subcommittee members have access, contact PW for permission). The finished StoryMap would be uploaded and hosted on the City's website <u>here.</u>

Aspects Discussed During This Meeting:

No updates at this meeting. LS asked if a deadline should be set for completing the work. LS noted that the Jane's walk was well-defined but that this would need to be narrowed down to several sentences and a photo to be use on the StoryMap GIS application. Moira suggested that the committee input their data directly into StoryMap. Mary noted that promotion of the tour would be important. Moira suggested that what is in the file now could be sent off to the City for publishing (i.e. there is a lot of content). PW noted another online tour example completed by City Green volunteers in the past, the <u>Cambridge Natural Heritage Tour</u> and that the Mill Creek walking tour would be housed on the same City webpage.

ACTIONS:

- 1. A subcommittee will meet to discuss the next steps
- 2. Finish the project content (i.e. the "stops" and complete the "low-tech version" in the same format as the <u>Historic Downtown Walking tour</u> (i.e. some text and a photo of each "stop").
- 3. PW to submit a request to City GIS Dept. to create the online StoryMap version and post to the City's StoryMaps webpage at this link
- 4. Seek permission from the City for installing small interpretive QR code steel signs along the route where people could use their phones to access information (and perhaps the small signs have some limited info as well).

3. Jane's Walks

Background: Jane Jacobs was an urbanist and author who was interested in building community. An event was created in her honour and it occurs the first weekend in May ("Jane's Walk"). Walks are planned and delivered all over the world on a variety of subjects and hosted by residents. In the past, Cambridge City Green members have developed and hosted walks on Mill Creek and Victoria Park.

Aspects Discussed During This Meeting:

Victoria Park Woodlot: (Linda, Zenen, Danesh, Karen, Kelly) <u>Victoria Park Forest</u> <u>Management Plan</u>. The group hosted the Jane's Walk on Sunday May 4th at 1pm. Eighteen people attended (over 50 had RSVP'd on the website). LS noted that the weather was cool and windy and likely discouraged some from attending. The group divided up the stops, and had 11 stops. Kelly noted it went well and the group was engaged and asked questions. Linda made some changes to the source document. The walk took 1.5 hours in total.

ACTIONS:

Linda to send PW the updated file.

4. Trees

TREEmendous Cambridge:

Background: <u>TREEmendous Cambridge</u> The tool (at the link) can be used to look up information on ~500 large trees on public properties with a diameter above 1 metre as well as ~63,000+ street trees. One can also view tree canopy coverage (in %) for schools, private properties, parks, etc. The information includes the species, diameter, Google Street View picture of the tree, address, and a statement about what the tree contributes in terms of "ecosystem services". In the past, Cambridge City Green hosted "urban street tree walks" across the city with walking routes maximizing the amount of large TREEmendous trees along the way and as a venue to introduce this "app" to people.

5. Victoria Park Forest Management Plan Implementation:

Background: The group outlined three projects, and initially discussed with City Forestry, based on the community engagement recommendations in the Victoria Park Forest Management Plan:

- A. Fence an area (10m x 10m), especially where oak canopy leaf density is sparse, a lot of Norway Maple saplings are present, and lily of the valley or similar species is the invasive groundcover (e.g. the site near the Blenheim Rd. which City Green visited in June 2024). Volunteers remove invasives mechanically; signs noting "Forest Regeneration in Progress" on fence plus any info for the public on the work involved; replant native oak seedlings at very high densities, go in each year and weed out invasives; each "plot" may take 5 years before the fencing is removed and seedlings are above browse heights (~2.5 m) and invasives are gone. Then repeat in other location(s).
- B. Forest edge/prairie wildflower area Remove walnut saplings and any other woody species (need City Forestry assistance with tree felling) and open up the canopy for the wildflowers. Create a 15ft. diameter planting site by laying

down thick cardboard and covering with 30cm of woodchips in October or November for a May planting event by 6-10 City Green volunteers establishing 30 one litre potted native wildfowers.

C. Educational projects - City Green volunteers Jane's Walk

Forest Restoration project ("A") and wildflower/pollinator project ("B") are on hold until direction, support, public notification, and training and a fenced off area can be created by Forestry and resources provided through the implementation of the Parks Master Plan for community-based projects. Also need Forestry assistance to remove the encroaching trees in the wildflower meadow area (project "B") which has defined windows for tree removal (due to Migratory Birds Act and nests).

Aspects Discussed During This Meeting:

The projects are still on hold until we can get resources and support from Forestry.

ACTION ITEMS:

- PW to ask City about a timeline for the forest invasives and wildflower area projects.
- PW request Operations remove (invasive) trees that are impacting/shading the wildflower planting area.
- PW to follow up with Forestry for a staff member to lead a forest walk in October.
- 6. Cambridge Community Clean-Up

Background:

Cambridge City Green has hosted a Community Clean Up Day for over 20 years. The event started in Hespeler (with Sandy Forsyth) and then spread city-wide. The group used to partner with Tim Hortons and since 2017 have hosted the event themselves in partnership with the City, Region, and Cambridge Library. Each year the City Green group improves aspects of the event. Participation generally ranges from 2,000 – 4,000 participants and 40-50 groups (schools, businesses, community groups); participation was highest in 2017-2019 with almost 6,000 participants and lowest in the COVID years with 1,000 participants.

Aspects Discussed this meeting:

- Participation:
 - 213 people requested supplies from the various library branches (April 12-26) with Queen's Square and Clemens Mill locations being the busiest. This

was the first year that this happened and was very successful from both the Library and City Green perspectives and should continue in the future;

- 217 volunteers requested supplies on the Clean Up Day (April 26th) (in 2024 this was 210); and,
- 2,189 / 42 groups requested supplies from March 1 May 1
- Total for Spring Clean Up = 2,619 participants (2024 = 1,617 participants)
- given World Clean Up day (September 20th) as well as summer camp / Neighbourhood Association clean ups it is anticipated that we will have over 3,000 volunteers this year which is almost double the 2024 participation.

- PW noted that the library distribution (April 12-26 went well and he received positive feedback from the branch location managers)
- PW noted that the Waiver sign up sheet was new this year and asked for feedback from CG members. He noted that groups were good at getting the signed waiver back. No issues at the booths with the waiver.
- SF noted the Hespeler experience.
- CS / LP / MM noted the Clemens Mill experience: people liked the smaller gloves but almost ran out; outfitted a church group.

- ND / ZT / KB: Queen's Square experience: it was surprising that this location had only 45 participants given over 100 last year.
- MG / DD noted the Preston experience (cold, but well attended and the Earth Day activities inside added participants).
- PW asked if small bags were needed? The white bags in the past were handy for hand out supplies and also have a QR code on how to get bags picked up. Linda noted that a reusable bag would be a gift / incentive and put supplies in it. What are the cost of the bags?

Recommendations for Next Year

- Revise the booth poster and simplify it for clarity (e.g. eliminate the DOs and DONTs and just provide the bag pick up, needle QR, and one sentence about leaving bags visible from road.
- Obtain a cart for taking supplies into library locations (or have two people available for setup);
- Advertise to the faith groups;
- Two volunteers for each booth is probably enough;
- Put location of City Green or Library on the waiver sheet so that numbers of participants can better be tracked;
- Have mobile signs say "Community Clean Up" (instead of "Community Clean Up <u>Day"</u>) to reduce confusion;
- Continue with the libraries offering supplies;
- Moira suggested that we have some kind of badge or extra recognition (e.g. a sticker, just for the kids, an affirmation...). Mary noted that stickers are popular for water bottles and laptops. Moira noted that school groups could design stickers. Sandy noted that participants thanked HER for being there this year.

ACTION ITEMS:

- PW to extend thanks, copying Chair LS, to Library branch managers for a successful pilot project distributing supplies April 12-26;
- PW to check supplies and order additional if needed (e.g. garbage pickers);
- Discuss volunteer recognition (September meeting);
- PW to look into producing small red bags with the slogo ("Only Cure for Litter is You") from the large litter bags.

7. Other Business / Information Items

LS asked if there were any other City Green projects or issues on people's minds.

- Mary asked if people would be interested in pursuing climate targets and community climate action through projects such as energy conservation, demand management, etc. Moira suggested making it an agenda item for June.
- Linda noted that last week was Volunteer Appreciation Week!

Aspects Discussed During This Meeting:

The projects are still on hold until resources and support from Forestry Services.

The group brainstormed a number of ideas around hosting an educational walk:

- September 24th (National Tree Day) or in mid-October for the Autumn colours or Doors Open event (October 18th). What date to align the event with?
- Could an expert be invited to lead the walk?
- KB noted trees in Europe have interpretive online resources.
- Identify trees through expert or participants or identify invasive species as a scavenger hunt or geocaching.
- Could put QR code on trees ("on the portal tree").
- Use iNaturalist or an app like Plant.net.
- Only 2 City Green meetings before now and the event so maybe the Jane's Walk script could be re-used in October (October 25th?) and a longer-term plan developed for other educational walks in the future?
- Amsterdam Echoes.xyz is an app that can be used (subscription?)
- LS, Zenen, Danesh, Mary, Kelly, Karen were the Jane's Walk leaders this May 4th

ACTION ITEMS:

- Work toward October Victoria Park walk event modelled after the Jane's Walk script with a preferred date October 25th.
- PW to follow up with the request to Forestry Operations on the three projects.
- 6. Cambridge Community Clean-Up

Background:

Cambridge City Green has hosted a Community Clean Up Day for over 20 years. The event started in Hespeler (with Sandy Forsyth) and then spread city-wide. The group used to partner with Tim Hortons and since 2017 have hosted the event themselves in partnership with the City, Region, and Cambridge Library. 8. Bird Friendly City Certification

Background:

Kitchener was recently certified as a bird friendly city by Nature Canada through collaboration by City Staff, Waterloo Region Nature, rare Charitable Reserve, Birds Canada, University of Waterloo and others. Is there interest in Cambridge pursuing this? Nature Canada has broadly outlined steps to take towards this certification on their <u>website</u> along with background information and including an <u>application</u> to be a bird friendly city.

Aspects Discussed this meeting:

Karen provided a presentation – cats, collisions, and loss of habitat are the main bird killers (eg. 90% of birds die in collisions with residential houses with only 1% from tall buildings). What can municipalities do? Habitat protection, tree management policies, work with other organizations, outreach and education and the certification program from Nature Canada (i.e. Threat reduction, by-laws, etc.). Aligns with Bee City, and with a cluster of cities surrounding Cambridge that are already certified (i.e. Guelph, Kitchener and others). It would also involve others in guiding us through the process of certification. ND mentioned High Performance Development Standards and bird friendly design are part of the Standards. There would be interest from CEAC to join and perhaps help with the policy aspects. David Gascoine, Waterloo Region Nature could give a presentation.

Re: Item for Discussion – Road Salt Usage

At its meeting of June 11, 2025, the Council of the Corporation of the Town of Bracebridge ratified motion #24-GC-068, regarding Road Salt Usage, as follows:

"WHEREAS chloride concentrations have increased by at least 0.5 mg/L in 80 of 274 (29%) of the lakes sampled by the District of Muskoka between 2018 and 2022, and by 15-fold in Lake Muskoka since 1970;

AND WHEREAS Queen's University scientist, Dr. Shelley Arnott, a leader in global research on the effects of road salt on lakes, has demonstrated that in Muskoka lakes, some important aquatic organisms are negatively affected at chloride exposure levels as low as 10 mg/L, far below the 120 mg/L long term or chronic exposure guideline;

AND WHEREAS roughly one quarter of lakes sampled by the District Municipality of Muskoka now have chloride levels above 10 mg/L;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Town of Bracebridge:

- 1. Commits to ongoing efforts toward the reduction of road salt as much as possible, while maintaining safety on roads, including public reporting on annual use, supporting local efforts to research the ongoing impacts of road salt, and assisting education efforts.
- 2. Urges the Province of Ontario to work urgently with key stakeholders to develop limited liability legislation, including enforceable contractor training and a single set of provinciallyendorsed standard Best Management Practices for snow and ice management on private lands; and to create and fund an expert stakeholder advisory committee to advise the Province and municipalities on the best courses of action to protect freshwater ecosystems, drinking water and infrastructure from the impacts of salt pollution.

AND FURTHER THAT a copy of this resolution be sent to the Premier of Ontario; the Ontario Minister of the Environment, Conservation and Parks; the Attorney General of Ontario; the Muskoka-Parry Sound MPP; Conservation Ontario; the Association of Municipalities of Ontario; the Association of Municipal Managers, Clerks and Treasurers of Ontario, the District Municipality of Muskoka; and other lower-tier municipalities in Muskoka."

WHEREAS the Town of Bradford West Gwillimbury recognizes the selfless service and enduring sacrifices made by Canadian Armed Forces veterans in the defence of our country and values;

WHEREAS the 2021 Census, conducted by Statistics Canada, identified more than 460,000 veterans residing across Canada, a significant population segment deserving of comprehensive, accessible, and modernized federal support;

WHEREAS Veterans Affairs Canada (VAC) currently administers income support programs to assist veterans in need, including the Income Replacement Benefit (IRB) program;

WHEREAS the eligibility threshold for the Income Replacement Benefit (IRB) program which was created in 2019—set at \$20,000 annually for a single-person household—fails to reflect today's economic reality, particularly in light of inflation, soaring housing costs, and the general increase in cost of living;

WHEREAS such low eligibility thresholds may disincentivize employment and community participation by penalizing veterans for earning beyond an outdated benchmark, thereby discouraging reintegration and contribution to civic life;

WHEREAS it is the duty of all levels of government to stand in unified support of our veterans and to advocate for policy changes that enable them to live with dignity and financial stability;

THEREFORE, BE IT RESOLVED That the Council of the Town of Bradford West Gwillimbury formally calls on the Government of Canada and all federal parties to increase the eligibility threshold for the Income Replacement Benefit (IRB) program from \$20,000 to no less than \$40,000 annually for a single-person household; and
