




Q2 What your gender?









Q5 Are you familiar with the current City of Cambridge Fireworks By-law?







Q6 How do you feel about the current regulations in the Fireworks By-law?






Q7 Would you support a complete ban on fireworks?






Q8 Would you like to see additional restrictions on fireworks in Cambridge?






Q9 What additional restrictions would you like to see implemented in the Fireworks By-law? (select all that apply)




