Presentations

Chris Wood, Region of Waterloo International Airport, re: Airport Updates

C. Wood provided an update on the airport expansion noting they are currently in various stages of building 8 new hangars, there will be additional space for aircraft parking, an increase in size to the aircraft apron and increase de-icing area. The terminal building will be doubling in size and will include a new baggage system, new technology and additional staff will be hired. Renovations are set to begin in the spring of 2022. C. Wood shared that the airlines have been very successful with no additional tax payer support. He noted there could be an increase in services to the Caribbean and a possibility of services to the US in the near future. Flair Airlines has been hiring within the Region employing hundreds including pilots, flight attendants and maintenance and ground crews. Discussion ensued regarding ongoing noise complaints

and it was noted staff continue to address resident concerns. There will be several public information sessions to take place in November.

Council Update

Councillor Reid and Councillor Wolf reviewed a few of the recently approved developments noting there is a great deal of growth lined up for the future.

Councillor Wolf shared that approximately 34,000 poppies were knitted by residents of the community for the Remembrance Day poppy art display.

Other Business

Councillor Wolf stated both Gary Berg and Tom Neil passed away recently. G. Berg was responsible for "Tubing on the Grand" and donated the profits to Rare Charitable Research Reserve. T. Neil served on the Committee of Adjustment for the City.

City/Priority List Items for Updates

a) North Cambridge Business Park

J. Goodram advised the \$30M invested on infrastructure continues to progress. The pump station is in place, the first phase of Intermarket Road has been constructed,

Allendale Road has been upgraded. The next phase of Intermarket road will service an additional 300 acres of employment lands in addition to the currently serviced 100 acres. It was indicated the City has site plans at various stages for over a million square feet of proposed industrial buildings. Angstrom Engineering has started construction of the new building which is the first building in this new business park.

b) Summer Road Closure and Patio Program

T. McWilliams advised the patio expansion program and the summer road closure that took place in Downtown Cambridge and Hespeler Village core areas was well received from the BIA and the community. Economic Development staff and the BIA are each reaching out to businesses and residents to conduct surveys for feedback to determine if the program will continue next year.

c) Development Charges By-law Update

J. Goodram explained there have been some provincial revisions to the Development Act and the City is undertaking a conformity exercise. The impact on the non-residential development charges is proposed as an increase \$0.04 per foot. A report will be brought forward to council in November regarding legislative changes followed by a staff report in the new year to discuss development charge exemptions in the core areas. A lengthy discussion took place on the financial incentive programs currently in place, types of development, construction costs, budget, property taxes and growth related expenses and impacts if the development charges are reinstated in the core areas. It was noted the last by-law update was in 2019 and that bylaw expires in 2024.

A brief discussion took place on the council approval for the development at Shade and Kerr Street.

d) EDAC Motions

Economic Development staff and Council members shared with the group the importance of EDAC. Council values the opinions of the committee and all recommendations are considered when making decisions on various projects that effect the City of Cambridge.


