Please accept this letter as support from Explore Waterloo Region for Flag Raiders Adventure Park. This attraction has been trying to reopen after having moved from their previous location in Kitchener and have been running in to roadblocks for the past couple of years. That coupled with the restrictions imposed on travel and operation during Covid, has meant that the operators have faced a loss of revenue and have had to lay off employees. Flag Raiders adds to the attraction of our community to visitors as well as providing a fun and healthy activity for residents. They are a true asset.

Explore Waterloo Region is the Destination Marketing Organization for the Region of Waterloo. We are a non-profit organization responsible for marketing our destination. We have been supporters of Flag Raiders as a way to encourage active, healthy living in our Region and we have actively promoted the attraction to visitors from across Ontario before the pandemic and the move to the new location.

This attraction not only brings visitors to Waterloo Region from more than 40 kms away (technically that is what is defined as a visitor), but they also host events that attract competitors from further afield to take part in tournaments on their site. Explore Waterloo Region has utilized the Event Impact Calculator model created by Tourism Economics to determine that the economic impact of three events held in 2019 was in excess of \$500,000. These events attract overnight visitors and generate business for restaurants and other attractions in the Region.

Flag Raiders Adventure Park is owned and operated by local residents of Waterloo Region and provides employment for 5 - 6 full time and up to 20 part time employees – mostly students. The attraction brings visitors who travel to play and stay to enjoy many other aspects of our community like restaurants, other attractions and hotels.
