#### **BACKGROUND:**

The Committee of Adjustment is a citizens group appointed by Council and governed by the Planning Act.

The Planning Act allows a municipal council to appoint a Committee of Adjustment to consider minor variances from zoning by-laws, permit changes to legal non-conforming uses, and to interpret generalized by-laws. The consent approval authority has been delegated to the Committee of Adjustment. This allows the Committee to consider consent applications, which include land severances, creation of a new lot, leases over 21 years, mortgage or charge, or partial discharge of mortgage or charge, foreclosure of exercise of power of sale, rights-of-way and easements over 21 years and lot adjustments and/or extensions.

#### **ANALYSIS:**

The City's Advisory Committee By-law 133-18 provides that a Striking Committee comprised of 7 members of Council will meet, as required, to review citizen applications for committees and appoint citizens to fulfill committee vacancies. Membership on Striking Committee includes the Chair of Budget and Audit Committee, Chair of General Committee, Chair of Planning and Development Committee, the Mayor and Acting Mayor as well as two (2) other Council Members, on a rotating basis.

On May 26, 2022 a Striking Committee meeting was convened by the Clerks Division to review and make recommendations on appointments to the two (2) vacancies on Committee of Adjustment. In attendance for the meeting were Councillor Ermeta (Chair of Striking Committee and General Committee), Councillor Reid (Chair of Planning and Development Committee), Councillor Mann (Chair of Budget and Audit Committee) in addition to Councillors Devine, and Mayor McGarry. Councillor Wolf was unable to join.

Appointments to the Committee of Adjustment are required at this time to ensure the Committee can continue to operate effectively and to meet legislated timelines for review and decision on applications.
