

Background


- The East Side Lands –
 Stage 2 Master
 Environmental Servicing
 Plan (MESP) was initiated
 in 2016.
- Includes lands north of Middle Block Road to Kossuth Road and from the Grand River to Speedsville Road. The broader study area continues north into the Township of Woolwich.

Background


- 115 hectares (284 acres) of land for primarily residential uses to be added to the Urban Area boundary in north Cambridge.
- Purpose of the MESP is to assist in identifying which lands should be added to the Urban Area boundary and how the lands will be planned and serviced.
- An outcome of the MESP is a Secondary Plan which identifies the permitted land uses and policies to guide development in north Cambridge.
- The studies associated with the MESP are near completion and the Secondary Plan process has been initiated by the City.

Background


- The Secondary Plan synthesizes the documents prepared as part of the MESP and provides more detailed planning objectives and policies to direct and guide development.
- The Secondary Plan is being prepared as an amendment to the Cambridge Official Plan.



Considerations in the preparation of the proposed North Cambridge Secondary Plan Official Plan Amendment include:

- Appropriate land use designations and policies;
- Transportation network, including road and pedestrian connections;
- Cultural heritage resources and Riverbank Drive as a scenic route;
- Natural features;
- Provisions for parks, trails and open spaces;
- Location of elementary schools;
- Prepared with input from the public, City staff and agencies.








Figure 2 - Collector Road Cross-Section
