

## THE CORPORATION OF THE CITY OF CAMBRIDGE

**By-law 22-XXX**

Being a by-law to amend By-law 22-044 being a By-law for the regulation of Traffic and Parking (Dando Ave, Gail St, Osborne St, Renwick Ave and Saginaw Pkwy)

**WHEREAS** the Council of the Corporation of the City of Cambridge passed By-law No. 22-044 on the 19th day of July, 2022;

**WHEREAS** the Municipal Act, 2001, S.O. 2001, c.25, Section 11(2), authorizes the passing of by-laws regulating traffic and parking on highways;

**AND WHEREAS** it is deemed expedient to amend By-law No. 22-044,

**NOW THEREFORE BE IT RESOLVED THAT the Corporation of the City of Cambridge enacts as follows:**

1. **THAT** Schedule 1, "No Parking", Part V of By-law No. 22-044 is hereby amended by **removing** the following:

Dando Avenue	both	a point 30m west of Water Street	a point 169m west thereof	7:30 a.m.– 8:30 a.m. Monday - Friday

Renwick Avenue	west	Walker Street	Gerrard Avenue	8:00 a.m. – 4:30 p.m. Monday – Friday September 1 – June 30

7. **THAT** Schedule 14, “U-Turns”, Part XII of By-law No. 22-044 is hereby amended by **adding** the following:

HIGHWAY	FROM	TO
Saginaw Parkway	62m west of Chipcase Court	Granite Hill Road

8. **THAT** Schedule 22, “School Bus Loading Zones”, Part XVIII of By-law No. 22-044 is hereby amended by **removing** the following:

HIGHWAY	FROM	TO	SIDE(S)	TIME(S) DAYS
Gail Street	a point 18m south of Currie Street	a point 108m southerly thereof	west	

9. **THAT** Schedule 22, “School Bus Loading Zones”, Part XVIII of By-law No. 22-044 is hereby amended by **adding** the following:

HIGHWAY	FROM	TO	SIDE(S)	TIME(S) DAYS
Gail Street	a point 18m south of Currie Street	a point 108m southerly thereof	west	8:00 a.m. – 4:30 p.m. Monday – Friday September 1 – June 30
Osborne Street	a point 40m west of St. Andrews Street	a point 45m southerly thereof	south	8:00 a.m. – 4:30 p.m. Monday-Friday September 1-June 30

10. **AND THAT** the by-law shall come into full force and effect upon the final passing thereof.
