#	Comment/Advise Provided	Project Manager Response
1.	Will there be accessible washrooms in the building? Recommend to add in adult change table if possible.	- Yes and noted
2.	Will the public tables and picnic shelter be accessible?	- Yes. Seating options, carousel tables with spaces for accessible devices, benches with backs
3.	Will there be enough space between bollards for wheelchair access?	- Yes. Depressed curbs with bollards near all accessible parking areas, AODA spacing on bollards
4.	Ensure access to community garden for wheelchair users. Proposed Smart Waterloo Region Innovation Lab, community gardens program.	- Noted. Stone dust and hard surfaces, maybe asphalt path, up middle of garden beds as proposed idea
5.	Ensure flush access from accessible parking space to sidewalk	- Noted.
6.	Ensure splash pad is accessible for children using assistive devices. Splash pads are a great idea, more accessible than a pool and safer for wheelchair users.	- Noted
7.	Will the playground amenities to come through Accessibility Coordinator and the CAAC be part of the RFQ?	- Yes in standard consultation practice, RFQ review
8.	Consider community rink	- Graded rink area for winter is a great idea, include in other concepts
