Government Relations and Consultation Activity

The government relations consultation review process was developed in order to provide a centralized way to coordinate and track opportunities for the City to provide input into Federal and Provincial legislative, regulatory, and programming considerations. This process is governed by the Government Relations Consultation Tracking Policy (Policy Number A09 ADM 008).

From January 1 to June 30, 2023, a total of five (5) government relations activities took place (Appendix A).

- Three (3) consultation responses were submitted to the appropriate legislative body
- Zero (0) were advocacy-related submissions, and
- Two (2) were reviewed with no response provided

External Grant Application Tracking and Results

From January 1 to June 30, 2023, there were sixteen (16) grant applications tracked through the Employee Grant Application Database (Appendix B).

- Three (3) were successful
 - o Tourism Relief Fund Second Application
 - o Canada Community Revitalization Fund
 - $\circ \quad \text{Settlement and Resettlement Program}$
- Five (5) were reviewed and determined to be not eligible
- Four (4) were unsuccessful
- Four (4) are in progress



There are many factors that affect external funding decisions, including the number of applications received relative to the amount of funding available. Cambridge has been very successful at obtaining grant funding previously. Staff will continue their commitment to the public value of sustainability, finding ways to lessen the financial burden on the taxpayer while also maintaining or enhancing City service levels.

Corporate Strategy will continue to monitor and track both advocacy and grant opportunities and will provide information on future activity in the form of a year-end Council Information Package (CIP) in six months' time.

Subject: JumpStart Accessible Multi-Sport Court Update

Comments

On July 19, 2022, through Council Report 22-005-IFS Jumpstart Accessible Sports Amenity Opportunity, Council directed staff to undertake public engagement and consultation with the City's Accessibility Advisory Committee to finalize a location for the Accessible Multi-sport Court based on the three Council approved sites and to complete the design.

Staff would like to provide Council an update on that consultation and next steps.

The public engagement was completed through the City's EngageCambridge website between May 15 and May 30, 2023. The site had 2,000 visits and the survey had 477 responses. The survey results on preferred location are:

Location	Percentage of responses supporting location
Hespeler Optimist Park (640 Ellis Road)	55%
Lions Can-Amera Park (305 Saginaw Parkway)	23%
Churchill Park (south-west section) (200 Christopher Drive)	22%

The City's Landscape Architect – Development attended the April 24, 2023 meeting of the Cambridge Accessibility Advisory Committee (CAAC) with the City's consultant to present the project and an overview of the three proposed sites. CAAC recommended Hespeler Optimist Park as the preferred location.

Additional factors considered in selecting the preferred location include:

• Site layout – is there space available and is significant work required to create the flat court area?



- Location within the site is it close to washrooms, other park amenities, would it replace an existing programmed space?
- Vehicular Access is parking available? Is accessible parking available?
- Pedestrian Access is there a connection to an existing sidewalk or pathway? Is the pathway accessible?
- Utilities and Servicing Are municipal and hydro services available? Might stormwater management be required?
- Cost Preliminary budgets for site works, servicing, washroom upgrades to provide accessible services, and sport court were prepared for each site.

Based on the survey results, recommendation from CAAC and the analysis of the additional factors, the Hespeler Optimist Arena has been selected as the preferred location for the Jumpstart project.

Staff are planning a Public Information Centre (PIC) to share the location with the public as well as to present options for the configuration of the court itself and ask for feedback on the court features. The PIC will be a hybrid set-up, with the information and survey available online through the EngageCambridge website and at an evening drop-in session being held at the Arena for those that want to see the information and ask questions in person.

The PIC material, including survey, will be available on the EngageCambridge site from September 5th to September 18th, 2023.

The in-person drop-in session will be held at the Hespeler Arena on Wednesday, September 6th, 2023 from 5:00 to 7:00 pm.

THAT Report 22-005-IFS Jumpstart Accessible Sports Amenity Opportunity be received;

AND THAT Council direct staff to undertake public engagement and consultation with the Accessibility Advisory Committee to finalize a location based on the three proposed sites and complete detailed design;

AND FURTHER THAT Council approve a new capital project with a budget of \$140,000 to be funded from the Capital Works Reserve Fund to complete public engagement and detailed design;

AND FURTHER THAT Council direct staff to include a capital construction project to build a Jumpstart accessible sports amenity, in partnership with Canadian Tire, as part of the 2023 Capital budget.

AND FURTHER THAT Council authorize the Mayor and Clerk to sign the Jumpstart funding agreement to the satisfaction of the City Solicitor.

EXECUTIVE SUMMARY:

Purpose

The City has been presented with an opportunity to receive grant funding for the expansion of park accessible amenities with an all-inclusive multi-sport court in an existing City park through the Canadian Tire Jumpstart program. This opportunity will provide a grant of up to \$500,000 for this project but will require a financial contribution

from the City that is not currently included in the capital budget forecast. This report outlines the details of this opportunity for Council's consideration and, if approved, seeks approval to proceed with a project that will leverage City funding to construct accessible park amenities with funding through the Jumpstart program.

Key Findings

Staff have identified three suitable locations that have sufficient space and minimal conflict with other existing uses that could be further developed to meet the requirements of the Jumpstart funding opportunity. These locations will need further review through public consultation and collaboration with the Accessibility Committee to select a site that best aligns with stakeholder input and requirements of the Canadian Tire Jumpstart program.

Financial Implications

With internal resources already committed to other approved capital projects, the internal capacity to accommodate the project management of this additional design assignment will delay the capital delivery of both the Angewood Park Playground Replacement project (A/00615-40) and Riverside Skateboard Park project (A/00959-40) until Spring 2023. It is estimated that retaining an external consultant to undertake stakeholder consultation, geotechnical, and detailed design work will cost in the order of \$140,000 and would need to begin as soon as possible. In addition, funding for this effort is not available within current approved capital or operating budgets. If this effort is to proceed in 2022, additional funding would be needed from the Capital Works Reserve Fund.

Based on the experience of other municipalities, the construction of a site to meet the requirements of the Jumpstart funding opportunity is likely to cost between \$800,000 and \$1,300,000 based on final site selection and detailed design. This is not currently in the Capital Budget Forecast for 2023 and, if it were to proceed in 2023, would need to be prioritized over other capital projects.

The 2023 – 2031 capital forecast identified 36 proposed projects worth more than \$32 million that were unfunded due to funding constraints. This amount is expected to increase during preparation of the 2023 Capital Budget due to rising inflation rates and supply chain issues. If this project is approved to proceed it would be prioritized ahead of two (2) other identified parks priority projects including maintenance and rehabilitation of existing park assets.


This project could result in the installation of a multi-sport accessible court within an existing park.

BACKGROUND:

Canadian Tire's Jumpstart program is interested in constructing an accessible multisport court within an existing suitable park space. Staff have met with representatives of the Canadian Tire's Jumpstart Inclusive Play Spaces Initiative to discuss an opportunity for a multi-sport court facility featuring: barrier-free access, covered seating areas, enhanced visibility with high-contrast colours and lighting, court surfacing and equipment supporting a variety of sports including:

- Basketball
- Pickleball
- Sitting Volleyball
- Tennis
- Volleyball
- Wheelchair Basketball
- Wheelchair Tennis

Canadian Tire Jumpstart multi-sport courts have been installed in a number of Canadian cities including Uxbridge, Ontario and Thompson, Manitoba. An example is shown in the image below.



The inclusive play program through Canadian Tire's Jumpstart initiative provides an opportunity for Cambridge to receive up to \$500,000 of goods and products that will transform an asphalt pad into a fully accessible multi-play sports amenity. The goods and products provided through Jumpstart include the following:

- Accessible tables (3)
- 12' Players bench
- Adjustable net system
- Uni-Court net system
- Tennis posts and net
- Fixed basketball systems (6)
- Portable basketball systems (2)
- 15' 5 Tier bleacher and sleeper systems (2)
- Court surfacing and base
- Perimeter fencing
- LED lighting
- Shade structure 100' x 20'
- Shade structure 25' x 18'

The Jumpstart initiative sponsored by Canadian Tire Mission is: Through our national ecosystem of partners and collaborators in communities across the nation, and our

unique relationship with the Canadian Tire Family of Companies, Jumpstart creates and supports programs that build better futures for kids.

The City will acknowledge Jumpstart's Gift as per schedule D and E of attached draft template gift agreement which includes naming rights, signage, branding on court component and host events to celebrate project milestones.

ANALYSIS:

Cambridge currently has a number of accessible park amenities as listed below:

11 accessible basketball courts:

- Brent Park
- Chaplin Park
- Churchill Park
- Greenway Park
- John Erb Park
- Laurence St. Park
- Santa Maria Park (practice pad)
- Timber Creek Park (practice pad)
- Vardon Park
- Weaver Park
- Witmer Park

4 fully accessible play structures:

- Riverside Park
- Churchill Park
- Victoria Park (Galt)
- Victoria Park (Hespeler)

Many other parks also have some accessible play components.

This opportunity would provide an expansion to accessible public sports play amenities to the residents of Cambridge.

A review has been undertaken to identify which existing parks have an existing sports court that could be converted or any other parks that have sufficient space that also meets as many of the expectations of the Jumpstart program as possible.

A summary of technical requirements of the Jumpstart program are as follows:

- A minimum 120' x 140' flat land prepared with base suitable for asphalt surfacing.
- An accessible washroom
- Accessible parking
- Accessible pathways between parking, washroom, and sports pad
- Electrical service and lighting potential.


A summary of general requirements to ensure usage of the facility is compatible with other existing uses.

- Sufficient distance or sound attenuation between court and adjacent residential units.
- Not within wetland or location prone to flooding.
- Does not conflict or displace other existing amenities/facilities.

The review by staff identified three possible locations that had sufficient space, provided some level of parking, and some level of access to washrooms. All locations would require some level of site works/construction to meet the requirements of the Jumpstart program. No location was identified that could support the Jumpstart opportunity without fairly significant site works.

The three most suitable locations are as follows:

- Hespeler Optimist Park
- Lions Can-Amera Park
- Churchill Park (South West Section)



Hespeler Optimist Park



Site Suitability Assessment

- **Sports Pad** The pad could be installed within the existing parking lot.
- **Washroom** An accessible washroom is available year-round within the adjacent arena.
- **Parking** Parking is available; however, additional designated accessible parking spaces may need to be created.
- **Pathways** This site has limited need for additional pathways.
- Lighting Electric service available for lighting.
- Proximity to Residential Units Some conflict with area residents expected.
 Some plantings may provide sufficient sound attenuation. This facility will be fenced and the hours of use can be restricted to mitigate noise complaints
- Wetland Not an issue at this location
- Conflict with Existing Uses Loss of parking spaces will be an impact during tournaments or full twin pad play and hall rental however, not an issue at other times.

Lions Can-Amera Park



Site Suitability Assessment

- **Sports Pad** The pad could be constructed where the existing play structures exist. A Capital project to replace the play structures in 2028 is proposed and the play structure is planned to be re-located within the park. This location would require some site grading and may require a small retaining wall.
- **Washroom** An accessible washroom is available in this park.
- **Parking** This park has shared parking with the adjacent school. Designated accessible parking spaces may need to be assigned.
- Pathways Good pathways exist, but, may need some re-configuration.
- **Lighting** Path lighting exists, additional wiring may be needed to support additional lighting.
- Proximity to Residential Units Good separation from nearby residents.
- **Wetland** Not an issue at this location
- **Conflict with Existing Uses** Limited conflict with existing uses and amenities. Coordination with school board will be required for water/power and parking.

Churchill Park - South West



Site Suitability Assessment

- **Sports Pad** The pad could be installed adjacent to the operations building with some site re-grading.
- **Washroom** An accessible washroom (with some limitations) is available and open all summer. Some re-work is required to make full accessible.
- **Parking** Parking can be constructed to re-purpose the former campground area.
- **Pathways** Would need to be constructed with site grading to connect sports pad and washroom and parking area.
- Lighting Electrical power available from adjacent operations building.
- **Proximity to Residential Units** Adjacent residents may have a concern with additional noise and lighting.
- Wetland Not an issue at this location
- Conflict with Existing Uses An existing baseball diamond may need to be shifted and/or additional outfield fencing installed to maintain separation between users.

EXISTING POLICY / BY-LAW(S):

There is no existing policy/by-law.

FINANCIAL IMPACT:

At this time, internal staff are committed to approved capital and operating items and do not have the capacity to undertake this additional design assignment. Should Council approve this additional design assignment the capital delivery of both the Angewood Park Playground Replacement project (A/00615-40) and Riverside Skateboard Park project (A/00959-40) would be delayed until Spring 2023. An external consulting firm would also need to be retained to undertake this additional design assignment and is estimated to cost \$140,000. Funding would need to be provided through a transfer from the Capital Works Reserve Fund.

A detailed construction cost cannot be determined at this time as a specific site has not been selected. Jumpstart would provide up to \$500,000 in the way of court surfacing costs and equipment, while the City capital cost to prepare the site with associated amenities to support the installation of the Jumpstart accessible multi-sports court could be in the range of \$800,000 to \$1,300,000 based on the experience of other municipalities, depending on the site selected. If approved, a capital budget for this project would be included as part of the 2023 Capital Budget. Due to the parameters of the funding agreement this project would be prioritized ahead of other identified parks priority projects including both the Lions Can-Amera Splashpad Design and Build project (A/00469-40) and the Sport Court Refurbishments of Greenway Basketball and Willard Tennis project (A/01210-40) totaling just over \$1M.

Additional operating costs to maintain awnings and periodic renewal of court surfaces in addition to regular inspections and repairs will need to be estimated and submitted with the capital project request. An annualized impact to operating over a 15-year period is anticipated to be in the order of \$20,000 for staffing, materials, supplies, and contracted services.

PUBLIC VALUE:

Leadership

This opportunity would enhance community wellbeing by providing additional accessible public amenities for residents of all ages and abilities to engage in outdoor sports play.

ADVISORY COMMITTEE INPUT:

Advisory Committees Consulted:

The Accessibility Advisory Committee will need to be engaged on this project to help assess suitability of a site as well as the design elements of the site.

PUBLIC INPUT:

Posted publicly as part of the report process.

Public engagement with area residents of potential sites will be included on this project should it be approved to proceed.

INTERNAL / EXTERNAL CONSULTATION:

There was no internal/external consultation undertaken.

CONCLUSION:

Although there is no proposed project to build an accessible multi-sports facility in the approved 2022-2031 Capital forecast, Cambridge has an opportunity to consider a partnership with the Canadian Tire Jumpstart program to build an accessible multi-sport court that will broaden the range of activities to residents with a premium facility.

If Council wishes to partner with the Canadian Tire Jumpstart program, two (2) currently approved 2022 parks projects would be delayed until Spring 2023 and in absence of an offsetting financial contribution to the capital program, would defer two (2) other parks capital projects previously approved as part of the 2022-2032 capital budget forecast.

We are pleased to announce that the governments of Canada and Ontario are investing up to \$1.5 million over two years to help improve the removal, handling, and disposal of deadstock across the province. The Increasing Deadstock Capacity Initiative application intake will be open from September 21, 2023, to February 1, 2024. All approved projects must be completed by February 1, 2025. You can find additional information, including how to apply, on the Agricultural Adaptation Council Website at info@adaptcouncil.org.

This program is being offered through the Sustainable Canadian Agricultural Partnership (Sustainable CAP). The cost-share funding initiative will help address some of the gaps identified in a Livestock Research Innovation Corporation (LRIC) report released this year and will provide opportunities for the deadstock industry to streamline operations and improve accessibility by increasing capacities and establishing new service standards.

Please note that expenses, where applicable, must meet regulatory requirements, including <u>Ontario Regulation 105/09</u> under the Food Safety and Quality Act, 2001 (FSQA), and <u>Ontario Regulation 106/09</u> under the Nutrient Management Act, 2002 (NMA), (or any applicable requirements under the Safe Food for Canadians Act for federally registered plants), and be suitable for use. The undertaking of these activities for cost-share funding may still be subject to regulatory approvals.

Re: Climate Emergency Just Transition Transfer (JTT)

Please be advised that the Council for the Township of Severn received correspondence respecting the Just Transition Transfer (JTT) at their recent August 9th, 2023 Council meeting.

Following discussion Motion C2023-042 was passed:

Moved by Councillor - Ward 3 Phil Brennan Seconded by Deputy Mayor Judith Cox

WHEREAS Canada's greenhouse gas (GHG) emissions are slowly starting to trend downward, but the reduction trajectory remains incongruent with what science and justice demands;

WHEREAS Canada must spend what it takes to confront the climate emergency, and there is an urgent need for Canada to spend more on climate infrastructure that would drive down GHGs and hasten the transition off fossil fuels;

WHEREAS Canada needs to make an audacious and hopeful offer to those workers and communities whose employment and economic security is currently tied to the fossil fuel industry (and to a lesser extent the auto, steel, concrete, and agriculture industries, etc., all of which face substantial transition challenges), and to Indigenous communities on the frontlines of fossil fuel extraction;

WHEREAS the federal government has introduced a *Sustainable Jobs Act*, but this Act needs to be paired with and backed-up by a substantial investment in the jobs of the future;

WHEREAS much of the climate infrastructure needed will come under provincial, municipal and Indigenous jurisdiction (renewable energy, grid upgrades, public transit, zero-emission housing, etc.), and training comes under provincial jurisdiction, but it is the federal government that has the greatest capacity to pay;

WHEREAS a new federal Climate Emergency Just Transition
Transfer (JTT) specifically linked to funding climate infrastructure
projects that would create hundreds of thousands of jobs, along
with training and apprenticeships programs for workers and those
leaving the oil and gas industry — would be a transformative
program that signals that Canada is indeed entering emergency
mode;

WHEREAS the JTT would be an annual transfer of approximately \$25 billion from the federal government to provincial/territorial, municipal and Indigenous governments, purpose-built to meet the climate emergency imperative to decarbonize our society, ensuring communities can fund the infrastructure and training needed to transition off fossil fuels, while creating thousands of sustainable jobs in a way that is specific to their needs and locale;

WHEREAS the JTT's distribution would be based on a formula linked to recent GHG emissions in each province (but fixed from that point onward, so as not to perversely incentivize continued high GHGs), recognizing that some jurisdictions face a more challenging task to transition their local economies;

WHEREAS the JTT would transfer federal funds to newly established just transition agencies in each province and territory — jointly governed by the federal government, provincial/territorial governments, municipal governments, and local Indigenous nations — and in some case directly to Indigenous nations, ensuring the transfer money is not simply absorbed into provincial or municipal budgets or used to displace other infrastructure or









training funds, but rather, ensuring the money is used for its intended purpose, and that fund are allocated in a manner sensitive to local climate action plans, the unique GHG profiles of each region, and to local labour market/training needs;

WHEREAS a JTT could provide significant, stable, multi-year funding for the climate infrastructure and training/employment needs of municipalities, Indigenous communities, energy utilities, public transit authorities and public housing authorities;

WHEREAS the federal government is welcome to title such a new transfer as they see fit (e.g. a Sustainable Jobs Transfer or a Climate Infrastructure Transfer);

NOW THEREFORE BE IT RESOLVED, that the Township of Severn formally endorses the call for a new Just Transition Transfer; and

THAT the Township of Severn urges the federal government to establish a new Just Transition Transfer, starting with a major financial commitment in the next federal budget; and will write to the federal ministers concerned expressing this support;

AND THAT this resolution be circulated to all municipalities.

Whereas the demand for alternative accommodations has resulted in an increased prominence of residential properties being advertised for short term accommodations through third party companies such as Airbnb and VRBO; a shift from the 'traditional' cottage rental historically managed by a property owner; and

Whereas over the past decade a flood of properties have been removed from the ownership and long-term rental market (*Canada Research Chair in Urban Governance at McGill University*) contributing to housing shortages, increased housing demands and increased housing costs resulting in housing affordability issues, including affordable rentals; and

Whereas short term rentals (STR) can be beneficial, when operated appropriately, by providing solutions for the accommodation industry that supports local tourism and small businesses as well as providing an opportunity for property owners to generate income from their residence (permanent or seasonal) using a convenient third-party system; and

Whereas STR's can create nuisances including noise, parking, high volumes of visitors attending a property, septic capacity and fire safety, for adjacent residential property owners who wish to experience quiet enjoyment of their property; and

Whereas research indicates that demand for STR's is increasing, in part due to vacationers choosing domestic travel options as well as the financial benefits to property owners, demonstrating that STR's are here to stay; and

Tel: 705 292 9507 Fax: 705 292 8964 Whereas there are no Provincial regulations in place governing third party STR companies resulting in a variety of regulations/guidelines being implemented at the local municipal level which creates inconsistencies, confusion and frustrations for both consumers and residents across the Province;

That the Township of Selwyn request that the Province move forward as soon as possible to legislate that all third party Short Term Rental brokerage companies, for example Airbnb and VRBO, appropriately manage and be responsible for their listings and to compel compliance that the Province establish the requirement for STR companies to require each rental listing to be registered and to pay an appropriate annual fee and that STR company provide this registry along with the collected fees to the municipality in which the STR properties are located which allows the municipality to be aware of all registered STR properties and to have access to funds for municipal expenses to enforce/respond to issues at a STR property; and further

That the Province require the STR company to de-list/remove the property from the company's listings so that the property cannot be rented where a municipality has identified and verified life, health and/or nuisance infractions including noise, fire safety, septic, etc...

That a copy of this resolution be sent to all Ontario municipalities for support as well as to Minister of Municipal Affairs and Housing Steve Clark, local M.P.P. Dave Smith and M.P. Michelle Ferreri.
