

THE CORPORATION OF THE CITY OF CAMBRIDGE

BY-LAW 23-102

Being a by-law to authorize the construction of certain works in  
the City as a local improvement

**WHEREAS** *Ontario Regulation 586/06, Section 2(1)* made under the *Municipal Act, 2001, S.O. 2001*, provides for municipalities to undertake works as local improvements for the purpose of raising all or any part of the work by imposing special charges;

**WHEREAS** the Council of the Corporation of the City of Cambridge deems it advisable to construct the various works as set out in Schedule “A” attached hereto as local improvements;

**WHEREAS** Council authorizes the funding of such works to be raised by the issue of debentures and obtaining of temporary advances to meet the cost of the works pending the completion;

**WHEREAS** it is intended that a portion of the cost of the project shall be a charge on the municipality as a whole;

**AND WHEREAS** Notice of the Intention of Council to undertake such work was provided to all impacted owners on September 29, 2023,

**NOW THEREFORE BE IT RESOLVED THAT** The Corporation of the City of Cambridge enacts as follows:

1. **THAT** the works as set out in Schedule “A” attached to and forming part of this by-law are hereby authorized to be constructed at the estimated cost set out in Schedule “A”.
2. **AND THAT** for the purposes of paying part of the cost of the construction of the Works, debentures not exceeding the sum set out Schedule "A" shall be issued and shall bear interest at the then current rate of interest on debentures intended to be sold at par and be made payable on the instalment plan within the term of years Schedule "A".
3. **AND THAT** the Treasurer or their designate may arrange with any bank for temporary advances of money to meet the cost of the work pending completion of it.
4. **AND THAT** the works shall be internally financed from a contribution from Capital Works Reserve Fund and the adjacent owners' portion of the works shall be repaid to the Capital Works Reserve Fund.
5. **AND THAT** the Engineer of the Corporation of the City of Cambridge or their designate is hereby authorized to make such plans, profiles and specifications and furnish such information as may be necessary for the execution of the work.
6. **AND FURTHER THAT** the work shall be carried out and executed according to the directions and orders of the Engineer or their designate.
